iii) Criteria of Award

INNOVATION AND EXCELLENCE in Corrugated Sector/ Development of new Product/ Manufacturing Process/ New market development and / or overall development of Corrugated industry.

iv) Who is eligible for Award

Any Corrugated Box Manufacturer or belonging to Complementary Industries viz. Kraft Paper Mills, Machinery & Testing equipment Manufacturers and Manufacturers of Adhesive, Stitching Wire, Printing Ink, Consultant, or anybody connected with the Corrugated Box Industry.

v) Nature of Award

- Trophy
- vii) <u>Selection:</u> The Panel of Judges to select an entrepreneur who has invested for betterment of Corrugation industry.

viii) Application & Selection conditions:

Any Regional Association may nominate an applicant for the award. Application can also be submitted by aspirant directly to Secretary FCBM. In such a case a report may be called from RA in whose jurisdiction the applicant hails from.

Following information needs to be provided with application.

- 1. Nature of the innovation or development.
- 2. Description of salient features.
- 3. Does it improve the quality of the product, if so, to what extent?
- 4. Does it help in the increase of productivity and reduce the labour, materials and other costs?
- 5. Difference in the percentage of cost of production pre- and post-innovation.
- 6. Has the innovation been accepted by the industry/customer?
- 7. How many innovative units sold so far. Names and addresses of the parties to whom sold?
- 8. Is the innovative product/ process applied in are in regular production?
- 9. Does the innovative product lead to import substitution and or is export oriented?
- 10. Does the innovative product lead to substitution of current packaging material with Corrugated?
- 11. Whether innovative product is ecofriendly and made of biodegradable material.
- 12. Innovation generated original or incorporated.
- 13. Write up with photographs and videos.
- 14. Any other information that can assist.

ix) Judges for Awards

- 1. Judges to be nominated by the Managing Committee of FCBM in or before the 3rd Meeting.
- 2. Three Judges from Corrugating Industry either members or otherwise.
- 3. Persons of eminence and with knowledge about Corrugated Box to be the Judges.
